2018-2020 - NCEQE Co-chaired the BICG TPG C on QA





#### TYPES OF VET PROGRAMS

# VALIDATION OF INFORMAL-NON FORMAL LEARNING

□Individuals can validate their informal/nonformal learning on levels 2-5, NQF;

- □TVET providers upon obtaining the special permit from NCEQE, can validate informal/nonformal learning for further education and employment purposes;
- □Requirements for obtaining special permit by the institution, is defined by the law, that includes mandatory existence of **certified validation specialist** in the institution; Certification process is administered by NCEQE;
- □Procedure and requirements for validation of informal/nonformal learning is defined by the law. Process is monitored by NCEQE and ends with issuance of state certificate of validation.



- □ Vocational Training prepares individuals for performing individual **tasks and duties** related to a profession (Law on Vocational education and training, article 6/b);
- □ Vocational Re-training ensures, that individuals acquire and/or develop competence to carry out **professional activities** in the same field (Law on Vocational education and training, article 6/c);
- □ Competencies acquired under authorized training or retraining programs do not require further validation and can be used for Vocational Education Programs.

## VOCATIONAL EDUCATION AND TRAINING QA

QA System

Providers are responsible to develop and administer Internal QA system that ensures permanent compliance with National Quality Standards

Internal QA

NCEQE is responsible to administer External QA system (Authorization) that validates effectiveness of internal QA system and also is based on National Quality Standards



#### **REGISTRATION OF CVET PROGRAM (SIMPLIFIED)**




- ✓If program is based of Vocational Education Program, that means the Vocational training or retraining program represents the compilation of learning outcomes from "bigger" program, that Vocational college, HE or GE institution is implementing under the umbrella of "big" authorization, they can address EQE for simplified registration, since "big authorization" stands behind;
- ✓NCEQE checks compliance of learning outcomes with "bigger" program and issues decree for registration for 3 years or refuses registration;
- ✓ Registration is cancelled if VET college, HE institution or GE school loses authorization or the right to implement the "bigger" program.

#### OBTAINING THE RIGHT TO DELIVER CVET PROGRAM

- ofunded by Micro-GEAR
- Not authorized legal entities or VET colleges, HE institutions or GE schools aim to deliver program that is not related to a "bigger" vocational education program:
- They apply to NCEQE and provide information (self assessment report) against national quality standards for CVET;
- EQE experts conduct desk study and pay a visit to the organization and produce expert report;
- Report is sent to National Council for CVET (under prime-minister) and NCEQE organizes oral hearing;
- National Council for CVET makes the final decision. In case of positive decision, program is introduced in the CVET program register for 3 years;
- Council can provide mandatory recommendations to the institution and set the time for monitoring.

## **DURING 3 YEARS:**



- CVET program is monitored via scheduled monitoring (based on EMIS data analysis and risk analysis, or based on the council recommendation on monitoring of particular provider or program);
- CVET program is monitored via non-scheduled monitoring (based on information provided to NCEQE by a trainee, trainer, employer, other responsible agencies or interested persons or based on public information);
- Provider is obliged to provide information in case of:
- Changing co-implementer (partner) of the program;
- Changing trainers;
- Changing name, volume, learning outcomes, location of implementation of program.

Depending on nature of changes it can be followed by monitoring.

#### KEY SYSTEM REPRESENTATIVES (STAKEHOLDERS)



- Government of Georgia approves National CVET Council for 3 years, adopts some regulations in VET which have impact on other ministries;
- Ministry of Education and Science approves by laws in VET;
- **LEPL NCEQE** responsible for QA of CVET, makes decisions on simplified registration of CVET programs and acts as secretariat for National CVET Council;
- **NNLP Skills Agency** initiates VET policy documents, provides administrative support for development of new professional qualifications and occupational standards (via SSOs), provides consultations and capacity building activities to CVET providers and makes decisions on budget financing of particular CVET programs;
- LEPL EMIS maintains central registers in VET (providers, programs, trainees, qualification documents etc), provides data for evidence-based decision making to the VET system;
- LEPL National Employment Supporting Agency (Under MoHS), uses only registered programs for training provision for state employment programs and provides access to budget finances as well as info based on trainee feedback.
